COVID-19 VACCINATION INFORMATION & DATA UPDATE

The Barren River District Health Department has confirmed a total of 28,876 cases, 26,188 of which have recovered. We have 396 deaths reported from COVID-19. We stand in solidarity with those affected during these difficult times. See the breakdown of numbers by county below. Please note that a decrease in numbers is due to the county of residence or case status being corrected/updated from what was previously reported.

The Barren River District Health Department is currently administering COVID-19 vaccines for individuals 18 years of age and older in all 8 of our county clinics. Effective March 24, 2021, our agency will schedule appointments for April for 18 years of age and older. Due to vaccine supply, vaccine clinics will occur on specific days for each county. Once the appointments are full for April, we will schedule appointments again in mid-April for the month of May.

- Enter first and last name, then enter a password and click Submit.
